Leadership Harrisburg Area will deploy teams of 7-9 professionals to selected organizations to help with the specified project. Examples of the types of projects that make for a good fit include: reviewing a strategic initiative, survey/audience engagement plan, video production, marketing plan, program/project analysis, etc. Hands-on service projects are not ideal for T.E.A.M. Projects and fundraising projects are not eligible for consideration. Your proposed project should provide a challenge for the LHA team to address in an 8-month period with work beginning in October 2024 and the final deliverable completed by May 2025. Leadership Harrisburg Area will email notification to all applicants in August, whether selected as a T.E.A.M. Project partner organization or not.
